Only current gym members are eligible for private lessons. A current gym member is defined as having an active gym membership (current registration). Gym registration is \$50.00 annually. Registration is valid for one year.

Private Lesson Pricing:

\$30 per half hour or \$60 per hour.

Private Lesson Policies:

- Private lessons can be scheduled directly through the coach.
- All payments are to be made at the front desk at the time of service (no exceptions).
- You must give the coach 24 hours' notice if you will not be attending your scheduled private lesson.
- Should you need to cancel due to an injury, please provide the coach with a copy of the Dr.'s note even if you have turned in a copy to the front desk.
- If for any reason the coach needs to cancel your private lesson and you are not given 24 hours' notice you will be entitled to a FREE private lesson from that coach.
